It is mutually decided that the evaluation and effectiveness of the agreement will be conducted jointly under the initiative of HoDs & Principals of the two colleges. Record of the activities will be kept individually by each Department. Resource sharing will be done with mutual consent.

### Funding

It is specified that this MOU is not a commitment of funds.

Sharing of infrastructure, sharing of expertise for academics will not have any commitments of funds.





### Duration

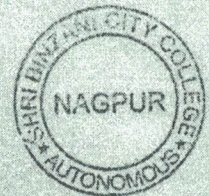
