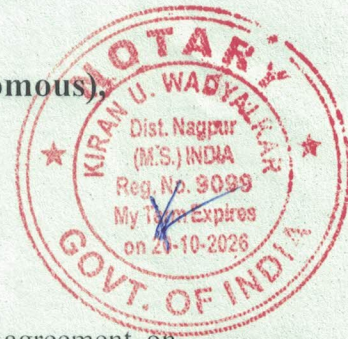

This Memorandum of Understanding (MOU) is entered into under the agreement on exchange and collaboration of academic activities on 29th day of September, 2025 between Shri Binzani City College (Autonomous), Nagpur (hereafter called as SBCC) situated in Nagpur, an institution run by Nagpur Shikshan Mandal and College of Social Work, Kamptee (here in after called CSW) run by Lord Budha Sariputra Dnyanprasarak Shikshan Sanstha.

Background

SBCC has achieved Autonomous Status from UGC from the academic session 2024-25 onwards. The Department of Psychology as a part of the Board of Studies in Humanities has designed its syllabi according to the needs of the students.

College of Social Work, Kamptee is affiliated to Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur (RTMNU) and follows the syllabi designed by the BoS of RTMNU.

However, both colleges share certain common modules on which both colleges can conduct Student Exchange Programs / Faculty Exchange Programs / Industrial Visits / Interactive Sessions / Field Projects / Research Projects.

Objectives of the MOU:

This Memorandum of Understanding (MOU) is established to foster comprehensive academic collaboration, research, and exchange programs between the departments. Its primary objectives are:

1. To enrich the teaching and learning experience for both students and faculty.
2. To facilitate the exchange of academic information, teaching materials, and scholarly publications.
3. To organize guest lectures, seminars, and workshops conducted by faculty from both departments.
4. To enable the exchange of faculty members for teaching, research, or joint supervision.
5. To facilitate industrial visits for students and faculty.
6. To identify and undertake joint research projects in areas of mutual interest.
7. To share resources, including departmental library and expertise, thereby achieving common academic goals.







Duration of MOU:

This MOU shall be in effect for a duration of **three years** from the date of signing of the MOU, i.e. 28/09/2028 and automatically extended after the expiration for the same duration, unless written intent of termination by either party is presented three months before the date of expiration.

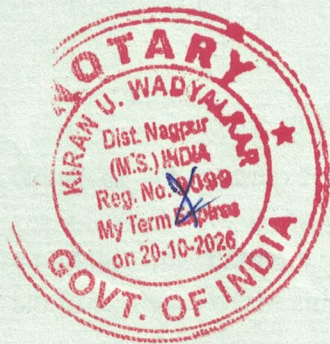
Funding:
